

Membership Waitlist Policy

1. Purpose

To manage incoming interest while offering flexible options towards full membership of the Club. This policy is designed to facilitate smooth onboarding and ensure continued engagement with the club during high membership demand periods.

2. Policy Outline:

• When member categories (e.g., 7 Day, 6 Day & 5 Day) reach capacity, a waitlist is opened for each. Current Membership Caps are:

Categories permanently closed: Lifestyle Social & Sunday	

- Positions on each waitlist are time-stamped.
- Applicants are contacted via email and phone when a spot is available.
- Applicants must respond within 14 days or be moved to the bottom of the list.
- Declining an offer more than once removes the applicant from the list.

3. Tiered Priority Waitlist Policy

Waitlist priority will operate as follows:

- 1. All applications are time-stamped once initial category fees are paid.
- 2. Provisional Ordinary Members (see provisional membership proposal next page) will have first access to each Ordinary Category in time stamped order.
- 3. Lifestyle Pay 4 Play Members who have expressed an interest (in time stamped order) in upgrading to an Ordinary Membership Category will be the next category considered should vacancies still exist.
- 4. All Junior Categories will automatically progress to the next category level provided a continuous Membership tenure is maintained ie Jnr 18 to Jnr 19 or Jnr 24 to Ordinary membership Category.
- 5. Get into Golf Members will progress to Lifestyle Pay 4 Play unless an alternate Expression of Interest or Provisional Category application is made.
- 6. On payment of the appropriate entrance fee other people can join a waitlist without being a either a Provisional or Pay 4 Play Member. These people will have a lower priority than all existing members mentioned in items 2-5 above.



Provisional Membership Policy

1. Purpose

The **Provisional Ordinary (7 Day, 6 Day or 5 Day) Membership** offers prospective members the opportunity to enjoy full playing and clubhouse privileges while awaiting availability of a full Ordinary Membership position. This category is designed to facilitate smooth onboarding and ensure continued engagement with the club during high-demand periods.

2. Eligibility/Membership Term

- Open to all individuals who are eligible for Ordinary Membership.
- Applicants must complete a membership application and be approved by the Redland Bay Golf Club Board.
- Provisional members will be invited to transition to full membership as vacancies arise in each category in accordance with the Clubs Membership Waitlist Policy.

3. Playing Rights and Access

- Access to the golf course subject to tee sheet availability 7 Day Provisional 7 Day Access, 6 Day Provisional Sun – Fri access & 5 Day Mon-Fri Access (exc Public Holidays).
- Eligible to participate in **club competitions**, excluding honour board events, major championships, and pennant teams.
- Social Rounds outside of Competition Play. Access to all practice facilities and clubhouse areas.
- **Booking Privileges:** Tee Sheet access 7 days prior to the day of play.

4. Fees and Charges

- The **Provisional Membership Fee** is the Fee set by the Board from time to time for the equivalent Ordinary Membership Category.
- Entrance fee is payable on completion of the nomination or change of category form.
- If the provisional period ends and no offer is made or accepted, no refund will be issued.
- To maintain position in the waitlist a Provisional Member must remain financial at all times. Membership will be prorated in the first year and require renewal at 30 September each subsequent year.

5. Transition to Full Membership

- When a full Ordinary Membership position becomes available, the provisional member will be contacted.
- The member must respond within **14 days** to confirm acceptance in accordance with the Membership Waitlist policy.

6. Conditions and Limitations

- Provisional members do not have voting rights, cannot hold office, and may not nominate new members.
- Provisional members must comply with all club rules, code of conduct or unpaid dues.

7. General Notes

- This policy is reviewed annually by the Board.
- All Provisional Members are expected to familiarise themselves with and adhere to the **Redland Bay Golf Club Constitution**, **By-Laws**, and **Code of Conduct**.
